# Saranac Clarksville District Library Minutes of Regular Board Meeting

  - a. Youth Services Coordinator staffing changes were not related to changes with the Homeschool Group services.
  - b. Changes to the Homeschool Group hosted by the library include:
    - i. Will be open to public attendance.
    - ii. No registration or registration limits.
    - iii. Advertising program to the public.
    - iv. May change the group name at discretion of the new Youth Services Coordinator, when hired.
    - v. Portions of the budget for this program will be reallocated to include more programs at the library.
    - vi. Scheduled time of the program will remain the same as it best fits the community's needs.
    - vii. Meeting Room Policy will be followed.

- viii. Group is on pause until the Youth Services Coordinator position is filled.
- 4. EPS is installing the fire security system in Saranac currently and Clarksville's install will be next.
- 5. Library Hours:
  - a. Both locations will be closed Nov 28-30 for Thanksgiving.
  - b. Clarksville will be open 11/29 2-5pm for a Make & Take Ornament craft.

## Program Update

- 1. Youth Services Coordinator position has been posted and received 15 candidates thus far. The position includes programs for children, Tweens, and Teens (not adults).
- 2. Budget
  - a. working to get this back on track by reallocating some budget lines
- 3. Expanding Programs:
  - a. Adult, Tween, Teen programs like: Creative Bug, Dungeons & Dragons

- b. Passive programing
- c. Working with the community so programs are not scheduled at the same time as events by other businesses and organizations.

#### **Public Comment**

- 1. A member of the Friends of the Library spoke on the topic of the groups/ support.
  - a. The group funded all summer programs for years and has supported the library in person and monetarily since 1992.
- 2. A member of the Homeschool group spoke on the topic of staffing & programming change.
  - a. Program has existed for many years, which expanded their access to materials and curriculum.
  - b. Homeschool group will continue to use the library but with reduced allocated budget lines.
  - c. Changes were implemented with the purpose to open program to everyone
- 3. A member of the Homeschool group spoke on the topic of staffing and programming change.
  - a. Family has been part of this group for many years.
  - b. Difficult to replicate public school atmosphere so this program enabled a school atmosphere
  - c. Wants to continue partnering with the library when a new Youth Services Coordinator is hired.
- 4. A member of the Homeschool group spoke on the topic of staffing and programming change.
  - a. Teen expressed personal feelings about staffing changes.
- 5. A member of the Homeschool group spoke on the topic of staffing and programming change.
  - a. Shared importance of the program and its use for the group.
- 6. President received a letter that will be opened, scanned, and emailed to the board for further review.
